**Constitution
of India.**

No.GS/2019/16/CRR/1096/2213/G.2 (part -1):- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby,-

(i) rescinds the Government Notification, General Administration Department No. GS/2016/38/CRR/1096/2213/G-2(Part-1), dated the 18th May, 2016; and

(ii) Makes the following rules further to amend the Gujarat Civil Services (Reservation of Posts for Women) Rules,1997, namely:-

1 (1) These rules may be called the Gujarat Civil Services (Reservation of Posts for Women)(Amendment) Rules, 2019.

(2) They shall be deemed to have come into force on the 14th January, 2019.

2 In the Gujarat Civil Services (Reservation of Posts for Women) Rules, 1997, in rule 2, -

(i) in clause (c), the word “ and “ occurring at the end shall be deleted ;

(ii) after clause (c), the following clause shall be inserted, namely:-

“(c-1) There shall be reserved in favour of women belonging to the Economically Weaker Sections thirty-three per cent. of the posts reserved in favour of such sections; and ” ;

(iii) in clause (d), for the words “Scheduled Tribes and Socially and Educationally Backward classes”, the words “Scheduled Tribes, Socially and Educationally Backward Classes and Economically Weaker Sections” shall be substituted;

(iv) in the Explanation, after clause (c), the following clause shall be added, namely:-

“(d) “Economically Weaker Sections” means such castes, classes and groups as are determined by the State Government as Economically Weaker Sections by Government Resolution,
