No. KP/274 of 2021 /PRR/102013/1847/KH: In exercise of the powers conferred by sub – section (5) of section 227 read with section 274 of the Gujarat Panchayats Act, 1993 (Guj. 18 of 1993), the Government of Gujarat hereby makes the following rules further to amend the Mukhya Sevika, Class - III, in the Superior Panchayat Service Recruitment Rules, 2013 namely:-

- 1. These rules may be called the Mukhya Sevika, Class- III, in the Superior Panchayat Service Recruitment (Amendment) Rules, 2021.
- 2. In the Mukhya Sevika, Class III, in the Superior Panchayat Service Recruitment Rule 2013, in rule 3,
 - (i) clause (a), for the figures and words, "35 years", the figures and word "37 years" shall be substituted;
 - (ii) in clause (b) for sub-clause (i), the following sub-clause shall be substituted, namely:-
 - (i) a Bachelor's degree in Home Science or Sociology or Child Development or Nutrition or Social Work or Master's Degree in Social Work obtained from any of the Universities established or incorporated by or under the Central or State Act in India; or any other educational institution recognised as such or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956."
