

GUJARAT PANCHAYATS ACT, 1993.

No. KP/116 of 2014/PRR/102013/1864/KH:- In exercise of the powers conferred by section 227 read with sub-section (5) of section 274 of the Gujarat Panchayats Act, 1993 (Guj.18 of 1993) and in supersession of all the rules made in this behalf, the Government of Gujarat hereby makes the following rules to provide for regulating the recruitment to the post of Gram Sevak, Class III, in the Superior Panchayar Service, namely :-

- These rules may be called the Gram Sevak, Class III, in the Superior Panchayat Service Recruitment 1. Rules, 2014.
- Appointment to the post of Gram Sevak, Class III, in the Superior Panchayat Service shall be made 2. by direct selection.
- To be eligible for appointment by direct selection to the post mentioned in rule-2, a candidate shall -3.
 - (a) not be less than 18 years and not be more than 30 years of age:

Provided that the upper age limit may be relaxed in favour of a candidate who is already in the Guaran Panchayat Service in accordance with the provisions of the Gujarat Panchayat Services Classification and Recruitment (General) Rules, 1998 :

Provided further that the upper age limit may also be relaxed in favour of a candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967;

- (i) either two years or three years Diploma in Agriculture or Bachelor in Rural Studies obtained from any of the Universities established or incorporated by or under the Central or State Act in India or any other educational institutions recognized as such or declared as Deenied University under section 3 of the University Grants Commission Act, 1956;
- (ii) the basic knowledge of computer applications as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967; and
- (iii) adequate knowledge Gu: -ati or Hindi or both.

- Notwithstanding anything contained in any rules, a candidate selected by direct recruitment under rule 3 shall be appointed on contractual basis for a period of five years on such terms and conditions as prescribed by the Government Resolution, Panchayats, Rural Housing and Rural Development 4 Department Resolution No. KP-12-2011-PRR-102010-2530-D, Dated, 15-06-2011.
- A candidate appointed under rule 4 shall be given the prescribed pay scale of the post of Gram Sevak, Class III after completion of contractual period on his performance being found satisfactory during the stipulated period of service on contract basis.
- A candidate appointed in accordance with rule 4 shall, during the stipulated period of service on contractual basis, be required to require to pass the ccc examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and 6
- A candidate appointed in accordance with rule 4 shall, during the stipulated period of service on contractual basis, be required to undergo pre-service training and pass the post-training examination 7. in accordance with the rules as may be prescribed by the Government.
- A candidate appointed by direct selection shall required to pass an examination in Hindi or Gujaran or both in accordance with the rules prescribed by the Government. 8.
- A candidate appointed by direct selection shall have to undergo such training and to pass such 9. examination as may be prescribed by the Government.
- 10. A candidate appointed by direct selection shall be required to furnish a security and surety bond in such form, for such amount and for such period as may be prescribed by the Government.
