GUJARAT PANCHAYATS ACT, 1993.

No.KP/19/2021/PRR/1196/1/KH:- In exercise of the powers conferred by section 227 read with section 274 of the Gujarat Panchayats Act, 1993 (Guj.18 of 1993), the Government of Gujarat hereby makes the following rules further to amend the Gujarat Panchayats Services Classification and Recruitment (General) Rules, 1998, namely:-

1. These rules may be called the Gujarat Panchayats Services Classification and Recruitment (General) (Amendment) Rules, 2021.
2. In the Gujarat Panchayats Services Classification and Recruitment (General) Rules, 1998 (hereinafter referred to as "the said rules"), in rule 2, in sub-rule (1) clause (i) shall be deleted.
3. In the said rules, in rule 6, in clause (a), the words "or the Selection Committee" occurring at two places shall be deleted.
4. In the said rules, in rule 7, in sub-rule (2), the words "or the Selection Committee" shall be deleted.
5. In the said rules, in rule 8, in the second proviso to sub-rule (5), the words "or the Selection Committee" shall be deleted.
6. In the said rules, in rule 9,-
 - (i) in the title, the words "or Selection Committee" shall be deleted;
 - (ii) the words "or the Selection Committee" shall be deleted.
7. In the said rules, in rule 10,-
 - (i) in sub-rule (1), the words "or the Selection Committee" shall be deleted;
 - (ii) in sub-rule (2), in clause (a), the words "or the Committee" shall be deleted;
 - (iii) in sub-rule (3), the words "or the Selection Committee" shall be deleted;
 - (iv) in sub-rule (6), the words "or the Selection Committee" occurring at three places shall be deleted;

- (v) in sub-rule (9), the words “or as the case may be, the Selection Committee,” shall be deleted;
- (vi) in sub-rule (10),
- (a) the words “or as the case may be, the Selection Committee,” shall be deleted;
- (b) In the proviso to sub-rule (10), the words “or the Selection Committee” shall be deleted;
- (vii) in sub-rule (11), the words “of the Selection Committee” and “or as the case may be, the Selection Committee” shall be deleted.
8. In the said rules, in rule 15,-
- (a) the words “or as the case may be, the Selection Committee”,
- (b) in the proviso the words “or the selection committee as the case may be” and “or the Selection Committee”. occurring at two places shall be deleted.
9. In the said rules, in proviso to rule 20, the words “or the Selection Committee” occurring at two places shall be deleted.
10. In the said rules, in rule 21, the words “or the Selection Committee” occurring at two places shall be deleted.
11. In the said rules, in the SCHEDULE-VI,
- (i) in entry at serial no. 3, for the words “Socially and Economically Backward class candidate”, the words “Socially and Economically Backward class and Economically Weaker Sections” shall be substituted;
- (ii) in note (2) for the words “Board/ Selection Committee, the word “Board” shall be substituted.
