No.KP/271/2021/PRR/1196/01/KH:-In exercise of the powers conferred by section 227 read with section 274 of the Gujarat Panchayats Act, 1993(Guj.18 of 1993), the Government of Gujarat hereby makes the following rules further to amend the Gujarat Panchayats Services Classification and Recruitment (General) Rules, 1998, namely:-

1. These rules may be called the Gujarat Panchayats Services Classification and Recruitment (General) (Second Amendment) Rules,2021.
2. In the Gujarat Panchayats Services Classification and Recruitment (General) Rules, 1998 after rule 22, the following rule shall be inserted, namely:-

“22A. Notwithstanding anything contained in these rules or in any other rules or orders relating to recruitment to any service or post included in the Superior Panchayat Service or Inferior Panchayat Service, the upper age limit prescribed for the appointment through competitive examination held for the purpose or by direct selection, to such service or post shall be relaxed by one year as far as it relates to the advertisement published by the Gujarat Panchayat Service Selection Board during the period from 1st September, 2021 to 31st August, 2022. This relaxation in the upper age limit shall be in addition and subject to the provision and relaxation available under rule 8 or any other rules or orders if any, made in this behalf.”
